Public Comments:

- Presentation (John Eichner & John Morse & Bob Puma: First Day Complete)
 - o Asks for a written statement of whether the SGA is in favor.
 - Shares concern no itemized cost; only shows full payment with everything summed up
 - o Wishes to increase transparency within the program in some way.
 - Handout that shows active participation from real students introduction to the program.
 - First day done by the course differs from the current program by having billing done in a lump sum payment.
 - Questions:
 - Laurie Ryan: What if a course does not have a textbook?
 - The charge is automatically removed from the bill if a professor says the class is open educational resources (OER).
 - Laurie Ryan: How is it based on credit hours?
 - o \$22.75 per credit hour NCCC
 - \$27.75 per credit hour NFCI if not OER
 - Program designed to be inclusive and fair for those who cannot afford their supplies by adding the charge to tuition, allowing financial aid to cover the cost.
 - If approved: Students will be informed of everything about the program via email – students can say yes or no and opt out at any time during the add/drop period.
 - Questions:
 - Nathaniel Moran: So, students are charged automatically?

- Yes The program will be called "Wolf Pack" and it includes all digital and physical materials. The physical materials will be packed in a box.
- The information of what is inside the box is transparent.
- Meghan Noonan: Are the books rented or purchased?
 - Yes, the books are rented, but there are exceptions for those required in multiple semesters – aims to work closely with the professors.
 - Plans to offer buyout option.
- John Morse: So, the program is all-in or all-out, correct?
 - o Yes
- Meghan Noonan: Is it on a per-semester basis?
 - Yes
- Bob McKeown: How does it work when a student switches classes during the add/drop period?
 - There are systems in place for this.
- Laurie Ryan: What does OER certified mean?
 - o The definition is being changed and will be posted online
- Laurie Ryan: Is this TAP eligible?
 - No, but PELL and loans will be included
 - The charge will appear on the bill and will be covered by aid/excess aid – it will be almost no different than how digital course materials are already charged.
- Hisan Milanes: What are the protocols for an unused book?
 - Unfortunately, there is no way to deal with that specific issue with this program, but the stress regarding the cost will be lifted
- This all came out from the high cost of books.
- This is an aggregate system that is based on the cost of all books students may use throughout their entire time at the college – huge savings
- Questions:
 - Andrew Binks: Why are nursing materials not entirely covered?
 - The high cost would skew the price.
 - Meghan Noonan: So, is there any limit?
 - \circ No
 - Heather Trumble: How long is this program locked in when the contract is signed?
 - One Year, but the current contract with an agreement until 2025 may be extended.
 - Laurie Ryan: What is the penalty for a book that is not returned?
 - o The penalty will be the same as it is now.
 - Laurie Ryan: What happens when a student drops out of college?
 - Books will be returned, and charges will be reversed.

- Laurie Ryan: What is the "General Fee"?
 - o It is a separate fee that includes other fees.
- Survey
 - 24000 respondents from the spring semester that overwhelmingly claim they support the program
- Emails there is a series of emails that keep students informed so they know if they want to stay opted in.
 - The email will not include information on specific course material costs – need to access the bookstore website to view this information. It is done this way due to the massive volume of various materials.
- Questions:
 - Andrew Binks: May we investigate the coverage of more materials?
 - Yes, we will investigate this
- o John Eichner:
 - Presents a survey
 - Most students did not have their books on day one.
 - Many students pay a lot for their books.
 - Renting books was not a concern for students.
 - Students were fine with pricing options within the survey.
 - Students were satisfied with their course materials.
 - Most students were satisfied with Barnes & Noble.
 - One third of students currently buy books from Amazon.
 - Have been discussing this program in-house for years
 - Wants students to be successful
 - Wants to make course materials very affordable for all students and relieve stressors – Where will I buy this book? How do I buy this book?
 - Renting provides very relevant value and allows students to move on through their education in a cost-effective way.
 - Increase revenue since money is no longer going to Amazon instead of the bookstore.
 - Questions:
 - Heather Trumble: Is there any demographic information in the survey?
 - Unfortunately, there is not any demographic data.
 - Laurie Ryan: Does the college receive a sign-on bonus?
 - Unfortunately, there is not.
 - Has received support from William Murabito
 - This program has a long-term benefit on student success and enrollment
 - The program is exploding in popularity in countless other colleges.
